5 Reasons to ADD the ScamShield app

- ✓ **Free-to-download and free-to-use**
- ✓ **Available for all phone devices**
- ✓ **Detects scam SMSes and blocks scam calls from blacklisted scam numbers**
- ✓ **Convenient channel for reporting scams**
- ✓ **Valuable opportunity to equip yourself and your fellow colleagues with additional protection from scams**



CRIME PREVENTION ADVISORY

- ✓ No government agency will ask for your personal or banking information through a telephone call or social media
- ✓ Never disclose your personal details (FIN) and banking details to anyone
- ✓ Contact the relevant government agency to verify
- ✓ Report any unknown transactions to your bank immediately

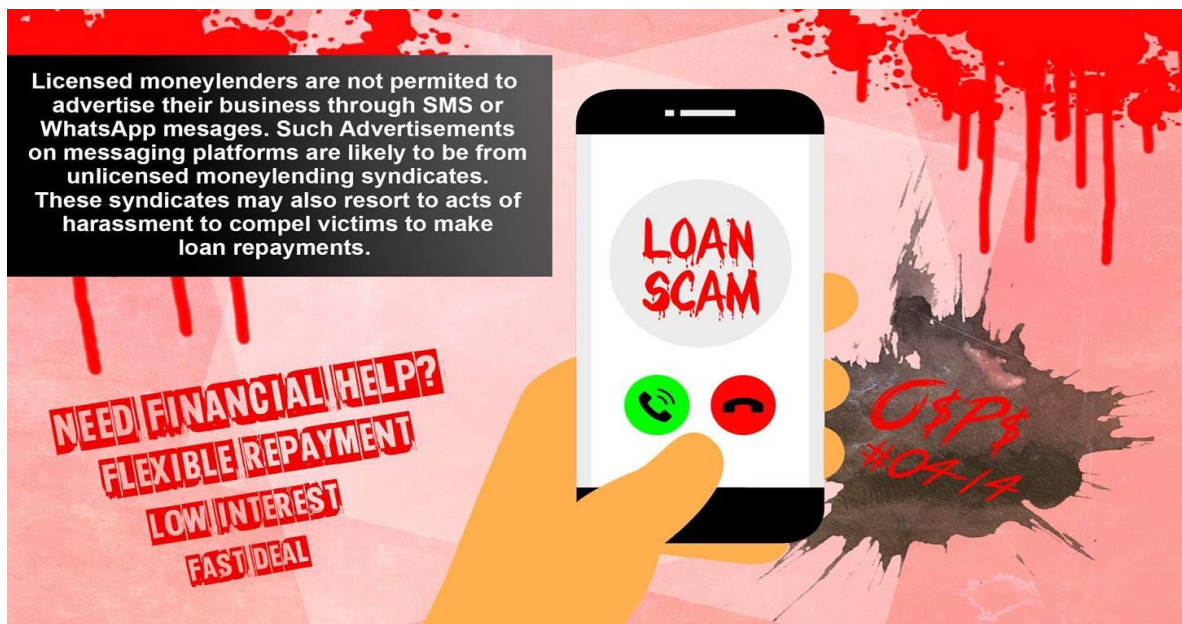

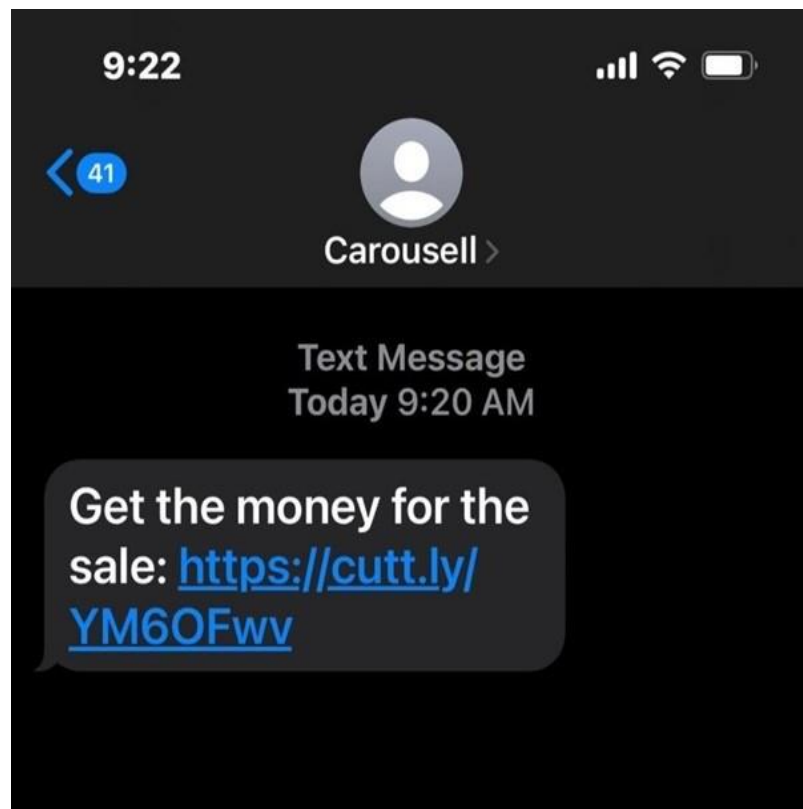
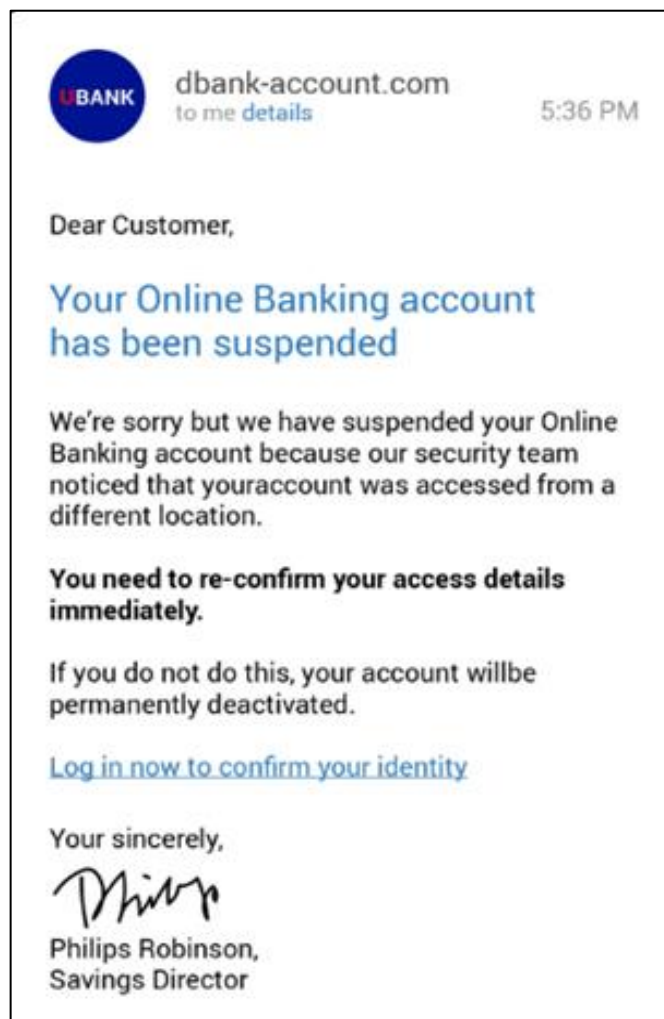
- ✓ **Be wary of good deals**
- ✓ **Buy from authorised sellers or reputable sources with good ratings and reviews**
- ✓ **Choose cash payment upon delivery**

Loan Scam



CRIME PREVENTION ADVISORY

- ✓ Licensed moneylenders would not ask for advance payment in processing the loan
- ✓ Licensed moneylenders are not allowed to offer loans via text messages, phone calls or social media platforms



CRIME PREVENTION ADVISORY

- ✓ Don't click on URL links provided in unsolicited emails or SMSes
- ✓ Always verify the authenticity of the information with official websites or sources
- ✓ Never disclose your personal or Internet banking details and OTP to anyone

SCAM ALERT

BRINGING YOU THE LATEST SCAM INFO



Tell the authorities to report the scam

- ✓ Report the scam by calling the Police Hotline or submitting the information online at www.police.gov.sg/iwitness
- ✓ Report and block the suspicious accounts or profiles where you encountered the scam
- ✓ Report the scam to the ScamShield app to keep others safe

Check with official sources to determine if it is a scam

- ✓ For more information on scams, members of the public can visit www.scamalert.sg or call the Anti-Scam Helpline at 1800-722-6688

Tell the authorities to report the scam

- ✓ **Inform your bank to try to stop the money transfer out from your account before reporting to the Police**
- ✓ **You may want to report to your employer or MOM and report the scam calls and messages via the ScamShield app**
- ✓ **Check for scam signs by visiting the [ScamAlert website](https://www.scamalert.sg)**
- ✓ **Tell your family and friends about scams by subscribing and sharing the latest scam alerts**

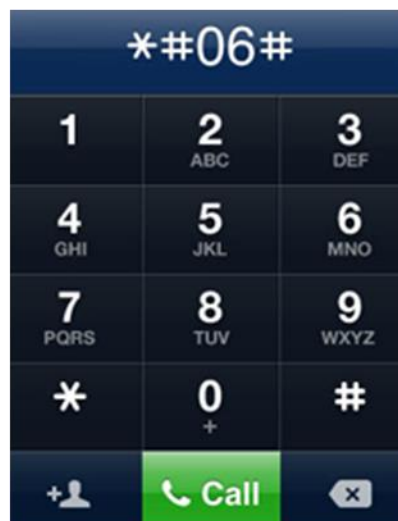
Other Safeguards

Beware of Individual Impersonating Police Officers



- ✓ Singapore Police Force officers are issued with an official warrant card
- ✓ You may verify the identity of the Police officer against his/her warrant card by calling 999

Know Your Mobile Phone's IMEI (International Mobile Equipment Identity)



- ✓ IMEI is a group of 15 or 17 digits unique to each mobile phone
- ✓ Key *#06# on dial pad to check IMEI number
- ✓ Keep a record of IMEI for reference

Theft in Dwelling



ALWAYS ensure that your valuables are not left unattended



ALWAYS secure your valuables in your lockers



ALWAYS lock your door when you are away, even for a short while

PENALTY

Theft in dwelling is punishable with a jail term of up to 7 years and/or a fine.

Bicycle Theft



Lock your bicycle with a good lock such as the U-Lock



Always lock your bicycle at a designated bicycle bay



LOCK IT or LOSE IT

Your bicycle is assessed to be **"AT RISK"** due to one or more of the reasons below:

-  Not secured appropriately
-  Not secured with a good quality lock

Keep It Safe!

PENALTY

Bicycle theft is punishable with a jail term of up to 3 years and/or a fine.

Robbery



- ✓ **Don't show your cash or valuables in public**
- ✓ **Avoid walking alone through dimly lit, quiet and secluded places**

PENALTY

Robbery is punishable with a jail term of up to 14 years and/or caning of not less than 12 strokes.

Outrage of Modesty



DON'T DO IT!

PENALTY

Outrage of modesty is punishable with a jail term of up to 3 years and/or a fine and/or caning.

PENALTY

Indecent exposure is punishable with a jail term of up to 3 months and/or a fine up to S\$2000.

Assault and Public Nuisance

- ✓ Drink responsibly
- ✓ Control your emotions
- ✓ Resolve matters amicably



DON'T DO IT!

PENALTY

Assault is punishable with a jail term of up to 12 months and/or a fine up to S\$5,000.

Public nuisance is punishable with a fine of up to S\$2,000.

Shop Theft



STEALING IS WRONG.

DO NOT DO IT!

PENALTY

**Shop theft is punishable with a jail term
of up to 7 years and/or a fine.**

Criminal Trespass



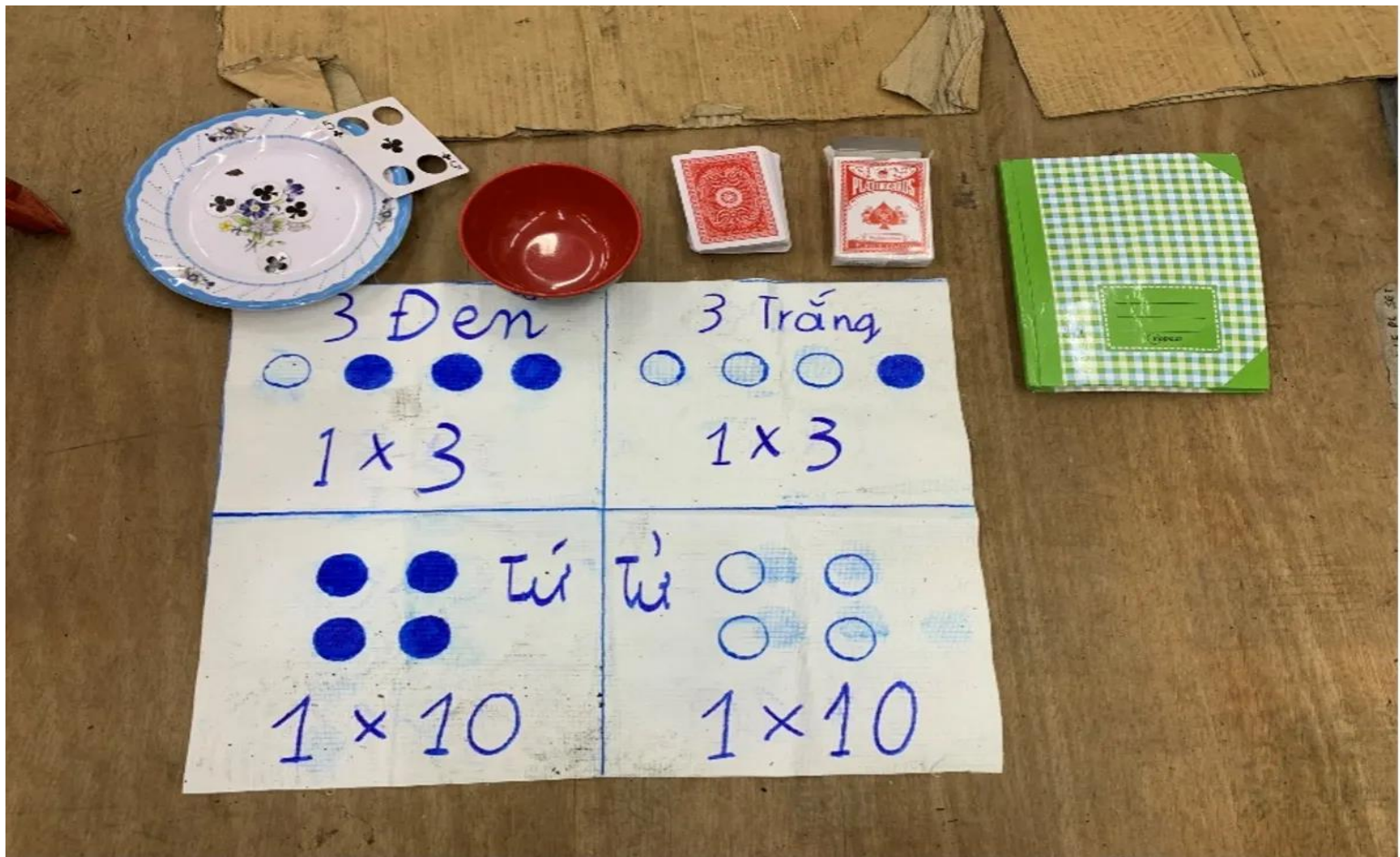
DON'T ENTER

PENALTY

Criminal trespass is punishable with a jail term of up to 3 months and/or a fine up to S\$1,500.

Illegal Public Gambling



**DON'T BE INVOLVED IN
PUBLIC GAMBLING**

PENALTY

**Illegal public gambling is punishable
with a jail term of up to 6 months and/or
a fine of up to S\$10,000.**



**No Consumption of Alcohol in Public Places from
10.30pm to 7am Daily**

PENALTY

Consuming liquor beyond permitted hours is punishable with a fine of up to S\$1,000 for a first-time offender.

Repeated offenders face a fine of between S\$1,000 to S\$2,000 and/or jail for up to 3 months.

x No Consumption of Liquor in Public Places

- From 7am on Saturday to 7am on Monday
- From 7pm on Eve of the Public Holiday to 7am of the day after the Public Holiday

PENALTY

Consuming liquor within Liquor Control Zones is punishable with a fine of up to S\$1,500 for a first-time offender.

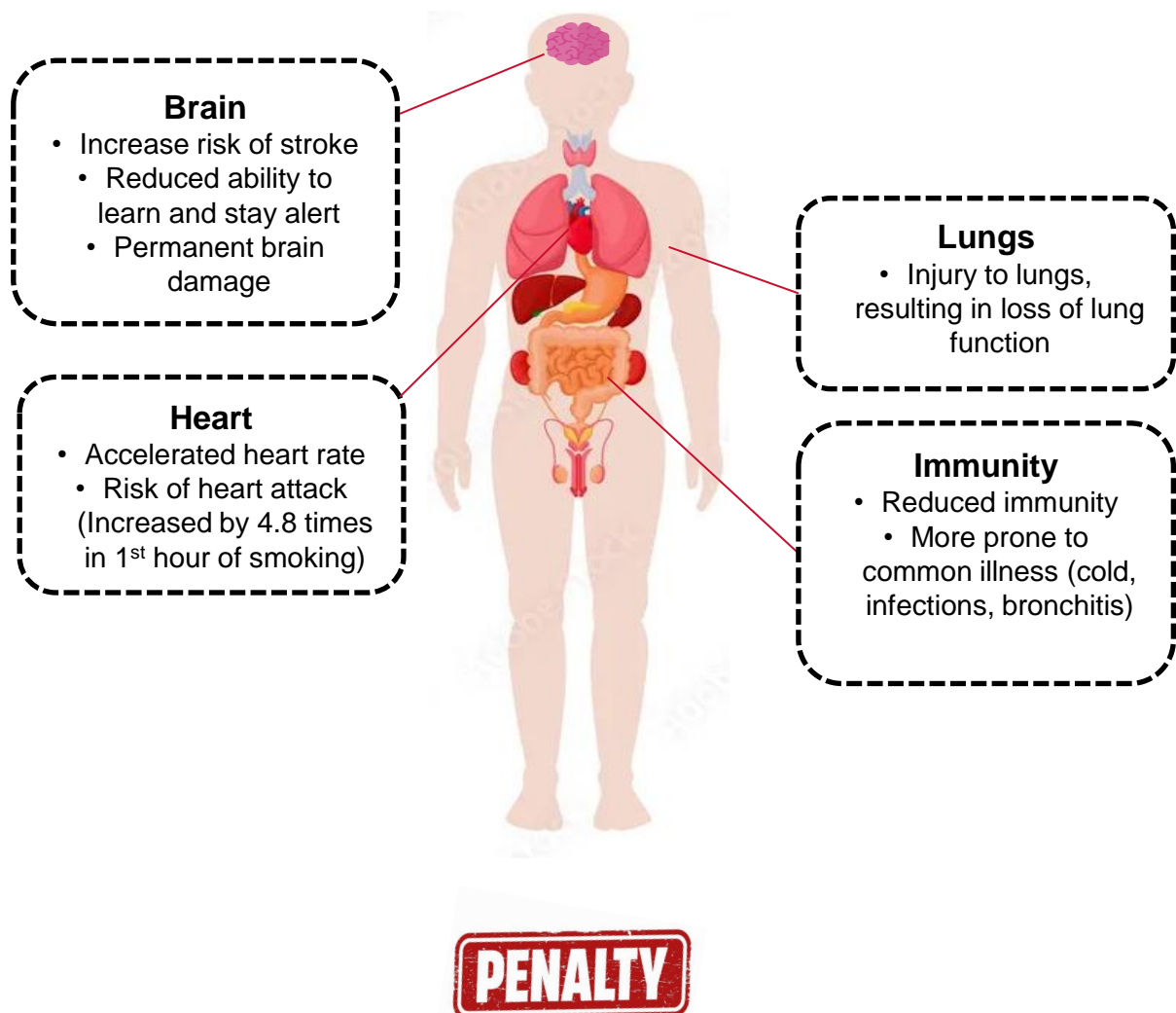
Repeated offenders face a fine of up to S\$3,000 and/or jail for up to 4.5 months.

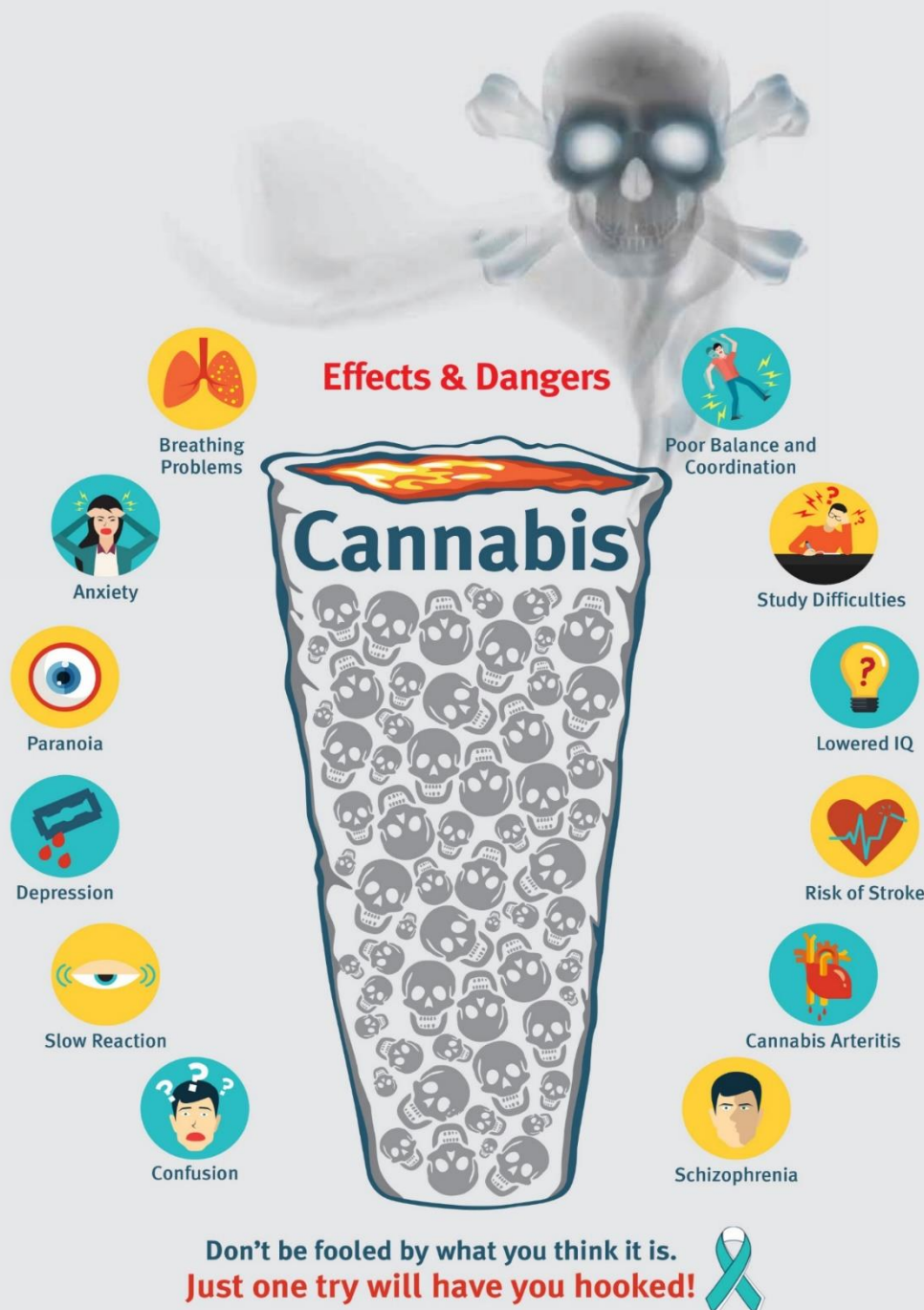
**Common drugs being misused:

Effects and Dangers



Offenders convicted of drug consumption will have their work permit cancelled. For more serious offences like drug trafficking, offenders may be sentenced to prison, caning and the death penalty.

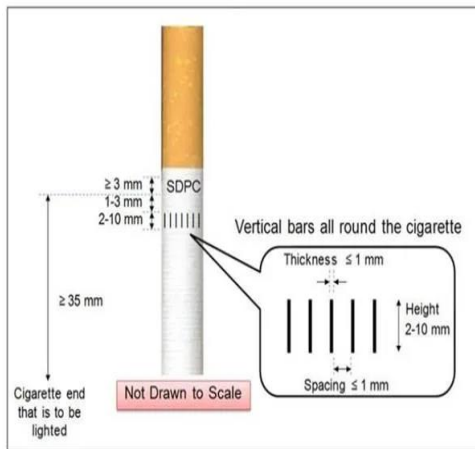

Duty-Unpaid Cigarettes



- X Don't buy or sell duty-unpaid cigarettes**
- X Singapore duty-paid cigarettes have the 'SDPC' mark and vertical bars on the cigarette stick**

PENALTY

Punishment for any dealings with duty-unpaid cigarettes under customs act is punishable with a fine of up to S\$5,000 and/or jail of up to 6 years and/or repatriation.

Vaping



Possession, use, or purchase of vaporisers/chewing tobacco in Singapore is an offence.

PENALTY



Punishable by a maximum fine of \$2,000 upon conviction under tobacco (control of advertisements and sale) act 1993.

Duty-Unpaid Cigarettes



DON'T LIGHT UP TROUBLE

BUYING, SELLING, CONVEYING, STORING, POSSESSING OR DEALING WITH DUTY-UNPAID CIGARETTES ARE SERIOUS OFFENCES UNDER THE CUSTOMS ACT AND GOODS AND SERVICES TAX ACT.

FINE UP TO \$5,000 AND/OR JAIL SENTENCE
